

Physician Consultation, Diagnostic Testing, Physical Therapy

EVALUATE & TREAT PER NDBC PROTOCOL: (EMR# MD)
 Initial physician consultation, Diagnostic Testing in our Balance Lab per NDBC protocols, Physical Therapy Evaluation, and a 5-10 week rehabilitation plan based upon initial findings.
 Monthly re-evaluations with a NDBC physician or physical therapist are made to determine continued treatment plans. All reports will be faxed to your office after each evaluation.

CONCUSSION EVALUATION PROTOCOL: (EMR# MD-PC)
 Initial physician consultation, activity restrictions plan, Post-injury ImpACT and Computerized Dynamic Posturography testing, Physical Therapy Evaluation, and a 2-5 week rehabilitation plan based upon ongoing symptoms. All reports will be faxed to your office.
 Ongoing activity restrictions will be monitored by a NDBC physician and a final return-to-play decision will be made using NDBC's "Return-to-Play" concussion protocol.

 Physical Therapy Evaluation, baseline testing using Computerized Dynamic Posturography, and a 5-10 week rehabilitation plan based upon initial findings. All reports will be faxed to your office.

POSITIONAL VERTIGO (BPPV) PROTOCOL: (EMR# PT-BPPV)
 Physical Therapy Evaluation, Video-Occulography evaluation of semi-circular canals for otoconia crystals, and canalith repositioning if indicated. If negative, our standard PT protocol above will be followed.



From The North:

Take Highway 65/Central Ave NE South to 105th Ave NE. Take a left on 105th Ave NE. Take a right onto Davenport St. NE. Follow to 101st Ave N and turn left.

From The South:


Take MN 65 N/Central Ave NE North. Look for the Thorne Brother's Fishing sign, take a right on 101st St NE. Follow to our building on the right.

From The West

Take US 10 east to MN 65/Central Ave NE. Turn left onto MN 65/Central Ave NE. Take right onto 101st Ave NE.

From The North / East

Head South on I-35W S. Take exit 30 for US-10 W. Take the MN-65/Central Ave exit, go North on MN-65/Central Ave. Turn right onto 101st Ave NE. **ALTERNATE** - Head South on I-35W S. Take exit 32 for 95th Ave NE. Take right, go 2 miles to 105th Ave. Take Left. Go West .7miles. Take a left onto Davenport St. NE. Follow to 101st Ave N and turn left.


Our clinic is located in the 6700 Building on France Ave., across the street from Southdale Mall on the west side.

From The North:

Merge onto I-35S. Keep Left to take I-35E S toward St. Paul. Merge onto I-694 E Via Exit 114. I-694 E becomes I-494 W. Take the Tamarack Rd exit, EXIT 58C. Turn left onto Tamarack Rd. Turn Right onto Bielenberg Drive. Turn left onto Currell Blvd. 7650 Currell Blvd, Suite 260, Woodbury, MN 55125 is on the left (before you get onto Valley Creek Road.)

From The South:

Merge onto I-35N. Keep right to take I35-E N toward St. Paul. Merge onto I-494 E. Take the Valley Creek Rd. exit, EXIT 59. Turn right onto Valley Creek Rd. Turn left onto Bielenberg Drive. Take the 1st right onto Currell Blvd. 7650 Currell Blvd, Suite 260, Woodbury, MN 55125 is on the left (before you get onto Valley Creek Road.)

From The West:

Merge onto 212/US-212 E. Merge onto I-494 E. Turn right onto Valley Creek Rd. Turn left onto Bielenberg Drive. Take the 1st right onto Currell Blvd. 7650 Currell Blvd, Suite 260, Woodbury, MN 55125 is on the left (before you get onto Valley Creek Road.)

From The East:

Merge onto I-94 W. toward St. Paul (Crossing into Minnesota). Take the County Hwy-13/Inwood Ave. exit, EXIT 250, toward Radio Drive. Turn left onto Inwood Ave. N./Country Hwy-80/County Hwy-13. Continue to follow County Hwy-13. Turn right onto Valley Creek Rd. Take the 3rd right onto Currell Blvd., then make first immediate right into building. 7650 Currell Blvd, Suite 260, Woodbury, MN 55125 is on the right.
